### Reproductive toxicity

In humans, oxytetracycline has been associated with congenital abnormalities such as neural tube defect, cleft palate, and heart malformation when used during the second and third months of pregnancy. Staining of teeth may occur in offspring of mothers treated with oxytetracycline during the second and third trimester of pregnancy. Studies in dogs and rabbits given material resulted increased frequencies of skeletal and other malformations in the offspring; however, studies in mice showed no increase in congenital defects.
